### **WAIVER AND RELEASE OF LIABILITY FOR VOLUNTEERS**

The Volunteer understands that the activities may include many hours of standing, inclement weather, strenuous lifting, and other activities related to the staging of a track meet.

**WAIVER AND RELEASE** I, the undersigned, hereby waive, release and discharge any and all claims or rights to claims for damages for illness, death, personal injury, and/or property damage which may have, or accrue to me, as a result of my participation. This Release is intended to discharge in advance the promoters, sponsors, the Community Foundation of Orange, its Board members, other volunteers, the officials, its attorneys, insurers, agents, and any involved municipalities, school districts, or other public entities (and their respective agents and employees), hereinafter "Released Parties", from and against any and all liability arising out of or connected in any way with my participation, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above.

**INSURANCE** The Community Foundation of Orange does not carry or maintain, and expressly disclaims responsibility for providing any health, medical or disability insurance coverage for the Volunteer. **EACH VOLUNTEER IS EXPECTED AND ENCOURAGED TO CARRY PERSONAL LIABILITY OR HEALTH INSURANCE PRIOR TO REGISTERING AS A VOLUNTEER FOR THE 2012 Foundation Games.**

**MEDICAL TREATMENT** Except as otherwise agreed to by the Community Foundation of Orange in writing, Volunteer does hereby release and forever discharge the Community Foundation of Orange and all the Released Parties from any claim whatsoever that arise or may hereafter arise on account of any first aid, treatment or service rendered in connection with the Volunteer's work for the Foundation.

**PHOTOGRAPHIC RELEASE.** Volunteer does hereby grant and convey unto the Foundation all right, title, and interest in any and all photographic images and video or studio recordings made by the Foundation during the Volunteer's work for the Foundation, including but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

**OTHER.** I understand that it is my desire to further the work of the Community Foundation of Orange by performing services as a Volunteer, specifically as a Volunteer for the 2012 Foundation Games. I undertake to perform said services as a Volunteer without compensation and that, in performing said services, I acknowledge that I am not acting as an employee of the Community Foundation of Orange and am not entitled to any Worker's Compensation coverage, and/or other benefits of an employee. The Volunteer expressly agrees that this Release is intended to be broad and inclusive as permitted by the laws of the State of California and that this Release shall be governed by and interpreted in accordance with the laws of the State of California. Volunteer agrees that in the event that any clause or provision of the Release which shall continue to be enforceable.
